 - Sharon addressed- mortgage payment is fixed, but the variable rate means the amount of principle we pay each month varies
 - Clarification on \$6000 childcare line item- FOC pays for childcare for FOC staff's children to be at CDC.
 - Clarification on \$8,000 church management system line item- this is Elexio, church data base
 - Clarification on \$5,000 electronic giving expenses- we pay 3.75% on each credit card transaction. Sharon clarified that ACH transactions do not cost FOC. Anyone interested in setting up automatic withdrawals through ACH should see Sharon.
 - Who is responsible for disbursing funds for missions? BOD
 - Clarification on FOC's compensation package for Senior Pastor- the feedback from the 2 pastors that declined our Call suggests that our package is competitive. The issue is that real estate in Northern El Paso County is very expensive, especially compared to housing prices in the Mid-West, where many of our candidates are coming from.
 - Motion and second to approve 2019 budget as submitted- **approved by voice vote**

<u>Spiritual Care</u> - This category includes the Pastoral Care expenses & the employees' Salary & Benefits.

Worship - This category includes Worship & Music Ministry expense.

Discipleship - This category includes Adult Discipleship, Student & Children's Ministries expenses.

Ministry Support - This category includes Welcome, Administration, and Property expenses.

<u>Mortgage</u> - This category covers the principal and interest payments for the mortgage. The mortgage is over budget because a rebate check of \$8,781 was received in January for the final quarter in 2018 for the LCEF rebate. The income was posted in Total Income so the net cost to the church is \$0.

The 2019 LCEF rebate program was changed effective January 1 from receiving an actual check to a reduced interest rate. Thanks to everyone who invested with LCEF in 2018, the 2019 potential savings on the mortgage interest is \$18,993. The current interest rate is 3.625% which is a .5% savings to the church due to our participation in the LCEF rebate program.



Children's Ministry Report

Sunday Mornings

Average Attendance: Nursery – 8 Kids 3:11 – 28 Children's Church – 19 Serving – 15

What the numbers do not reflect is the growth in relationships, knowledge, and compassion that has been shown over the last 6 months! The kids and CM team have built relationships with one another. They have been supporting two kids through Compassion International with their offering and letters.

Special Events

Egg Hunt – About 150 people participated in our Egg Hunt this year. Those attending were able to hear a bit of the Easter story and enjoy time with family and friends.

VBS – 230 kids registered and 112 are serving – about half of the kids did not list a church home or entered "none." This program is a great mission opportunity for FOC!

Child Development Center Report

Constitutional Scope: To administer the Child Care, Preschool, and Day School programs. **CDC Leadership Team:** Lauren Stadjuhar, BOD - Mary Willis - Amy Janisse, Director

Items of Note for 2019

- The CDC is a huge community outreach with less than 8% of our student families actually being FOC members. To ensure that we are able to continue to meet the growing needs of the community, we are constantly reevaluating our programs and making programing changes as needed. This summer we are expanding from 12 to 13 classrooms and will be moving classrooms around to better meet the current age group needs of the community.
- We currently have 189 students enrolled, 24 teachers, and 14 substitute teachers. Many of our programs are at capacity this year with a waiting list!
- We have partnered with FOC Children's Ministry's Mission Outreach by designating our chapel offerings to assist with the monthly cost of sponsoring FOC's two Compassion Children.
- During his last chapel service with the children, Pastor Kirk was shown much love appreciation from the children as they thanked him for all he did during his time of service with us at FOC.





- We are so excited to have Pastor Moreno at FOC! The children look forward to chapel time with him as well as his frequent classroom visits. Families love that during the school-year Pastor Moreno stands at the door a few mornings a week, greeting and welcoming them as they drop-off or pick-up.
- We are very thankful for recent playground beautification and improvements as part of Jacob Vollmer's Eagle Scout project. He built three beautiful new planter boxes, freshened up our sand and mulch boxes, stained/painted our wooden benches, and worked on our flagstone. If you have not seen our playground, please stop by and take a look.

This Summer, our Chancel Choir Director, Katy Mariotti is helping coordinate our "Special Summer Music" series for our Classic service, in which folks can perform special songs during service while the choir is off for the Summer. Our Chancel Choir is looking forward to another great choir season starting in the Fall.

The Modern Worship Team is thriving and learning new songs and looking toward getting prepared for the Fall and Christmas season already. Maria continues to serve beautifully as our organist and pianist for the Classic Service. It's exciting to have Pastor Moreno here at Family of Christ and to brainstorm creatively for the future! We've gradually been working on the staging for the chancel area in the *South Sanctuary* to best serve and honor the Lord in the context of both worship styles. This has been a work in progress, but we're definitely getting there!
